Subterranean Termite Service Agreement

Sentricon Terms And Conditions

- A) Chase Away; in compliance with all applicable Federal, State, and local laws, rules, regulations and all applicable recommendations contained in literature provided by Dow AgroScience will perform the following:
- 1) Install Sentricon termite bait stations in the soil around the outside perimeter of the structures specified above.
 - 2) Install Above Ground pre-baited stations to accessible active termite evidence.
 - 3) During the term of this agreement, add termite bait to and remove it from the stations as appropriate.
 - 4) During the term of this agreement, inform the customer of any new or increased activity and any maintenance performed on the stations.
 - 5) Upon installation, monitoring of the Sentricon System will be in accordance with current bait label.
 - 6) If payment is not made in full within 30 days of billing installment, a late charge of 1.5% per month 18% per annual on the unpaid balance will be added. Customers failure to pay shall terminate this agreement and relieve Chase Away of any further responsibility.



B) Dow AgroScience Ownership of Sentricon System Components:

- 1) All the Sentricon System components are and will remain the the property of Dow AgroScience. The customer has no rights to any of the components, other than the right to their use as installed by Chase Away on the customers premises under this agreement.
- 2) On expiration or termination of this agreement, Chase Away and Dow AgroScience or its representatives are authorized by the customer to retrieve from the customer’s premises, those stations and other components contained therein for appropriate disposition, _____ **Customer Initials**
- 3) If Chase Away, for whatever reason, ceases to represent or to be authorized to represent the Sentricon System, they will:
 - A) Notify the customer in writing.
 - B) In the event Chase Away terminates its relationship with Dow AgroScience, and ceases to remain an authorized operator of the Sentricon System, the customer will have the opportunity to work with the local sales representative from Dow AgroScience, who will transfer the account to another authorized operator in the area.
 - C) Retrieve or advise Dow AgroScience or it’s representatives where to retrieve the components from the customers premises and grant Chase Away and Dow AgroScience or its representatives reasonable access to the premises for removal of the components.

The Sentricon System involves initial installation and monitoring, colony elimination with terminate bait, and subsequent monitoring for continuous protection from new termite colonies.

- 1) The customer agrees to maintain the areas protected by the Sentricon System from wood, trash, lumber, direct wood-soil contact, standing water, eliminate faulty plumbing leaks or leaks under the roof line.
- 2) The customer also agrees to contact Chase-Away on any Additions, Alterations, or other changes to the structures under the Sentricon System. Additional services and fees may be added at the home owner expense.
- 3) Chase-Away has the right to adjust the renewal fee after the first 5 years from installation date.
